- Complaint procedure

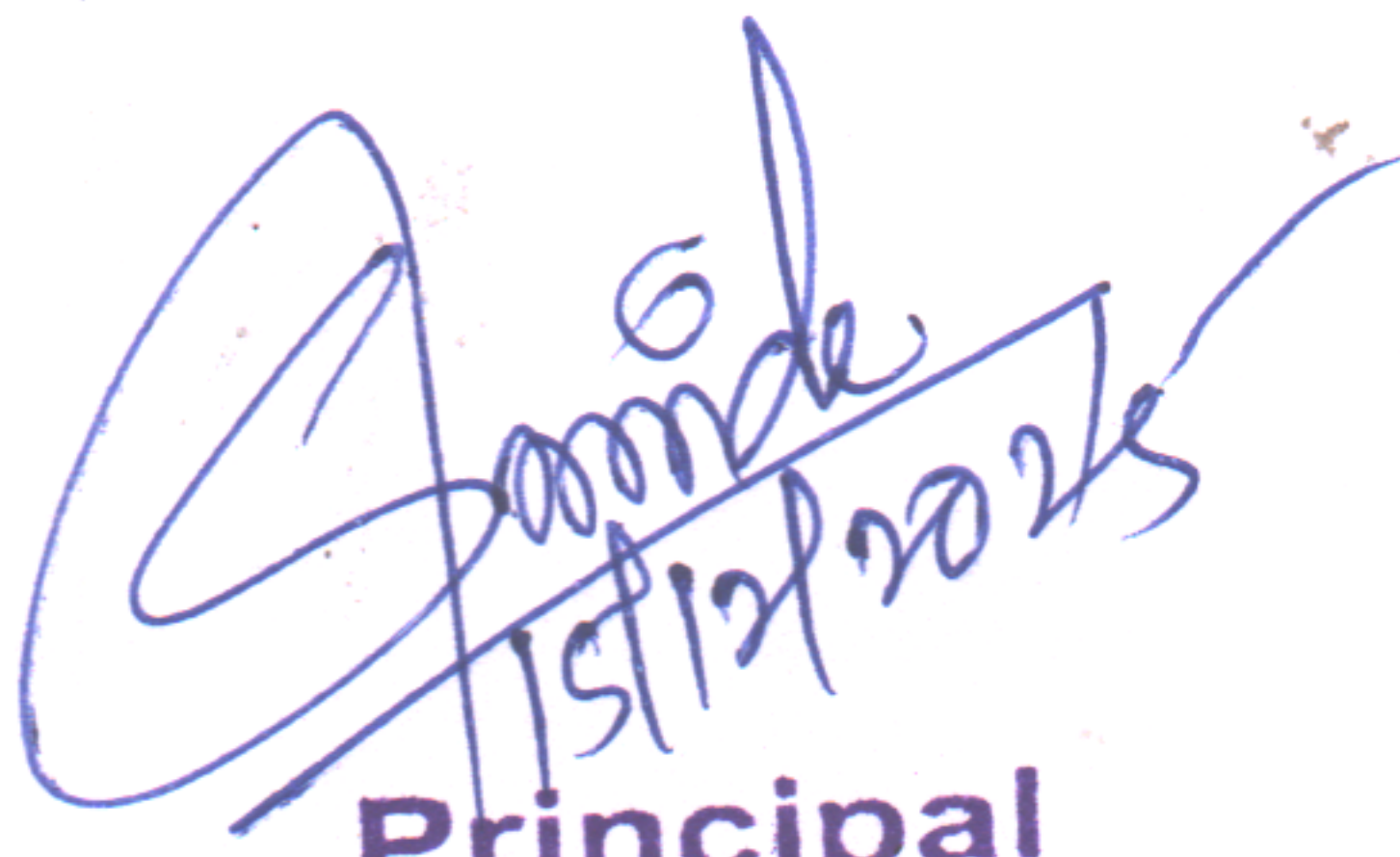

2. Discussion on Anti-Ragging Regulations:

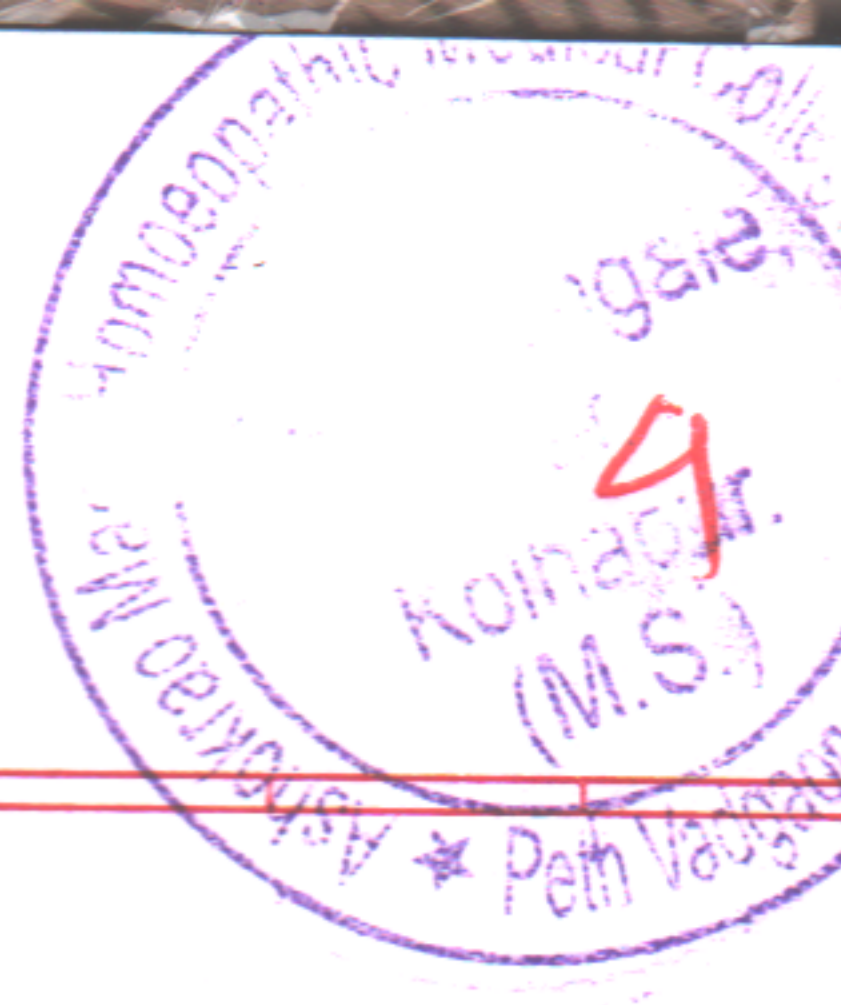
The committee discussed the UGC Regulations on Curbing the Menace of Ragging and emphasized zero tolerance towards ragging.

No other matter was discussed.

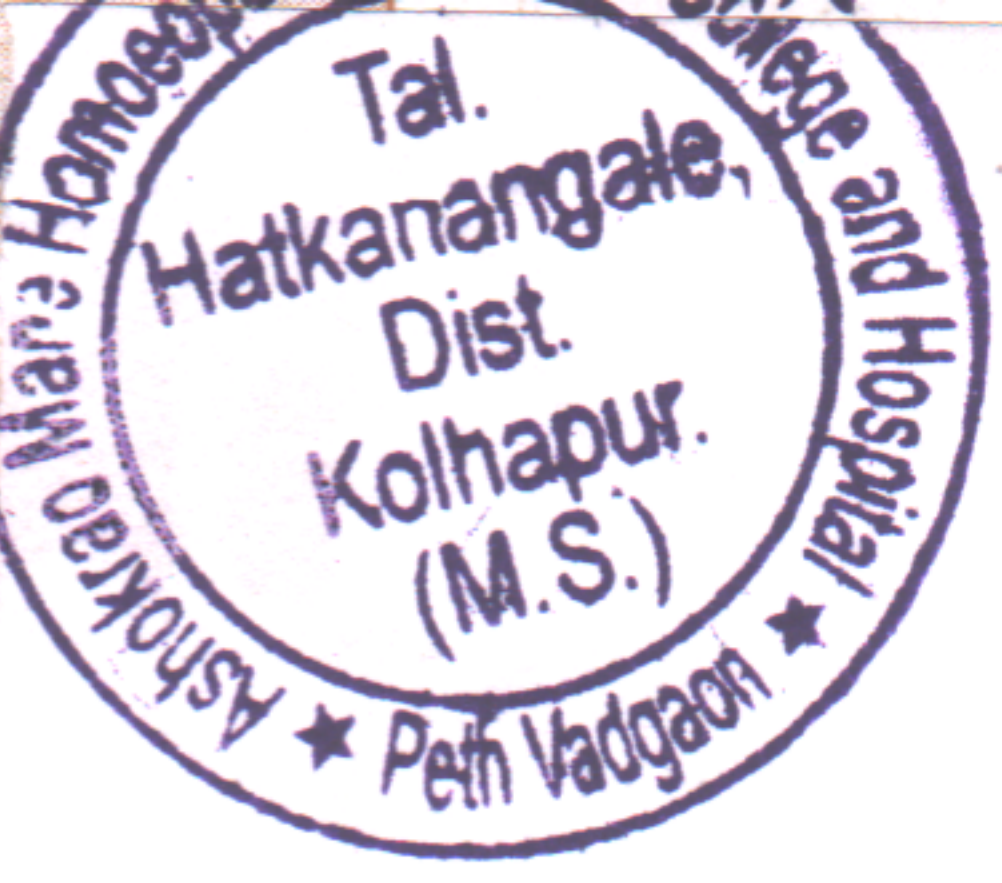
