

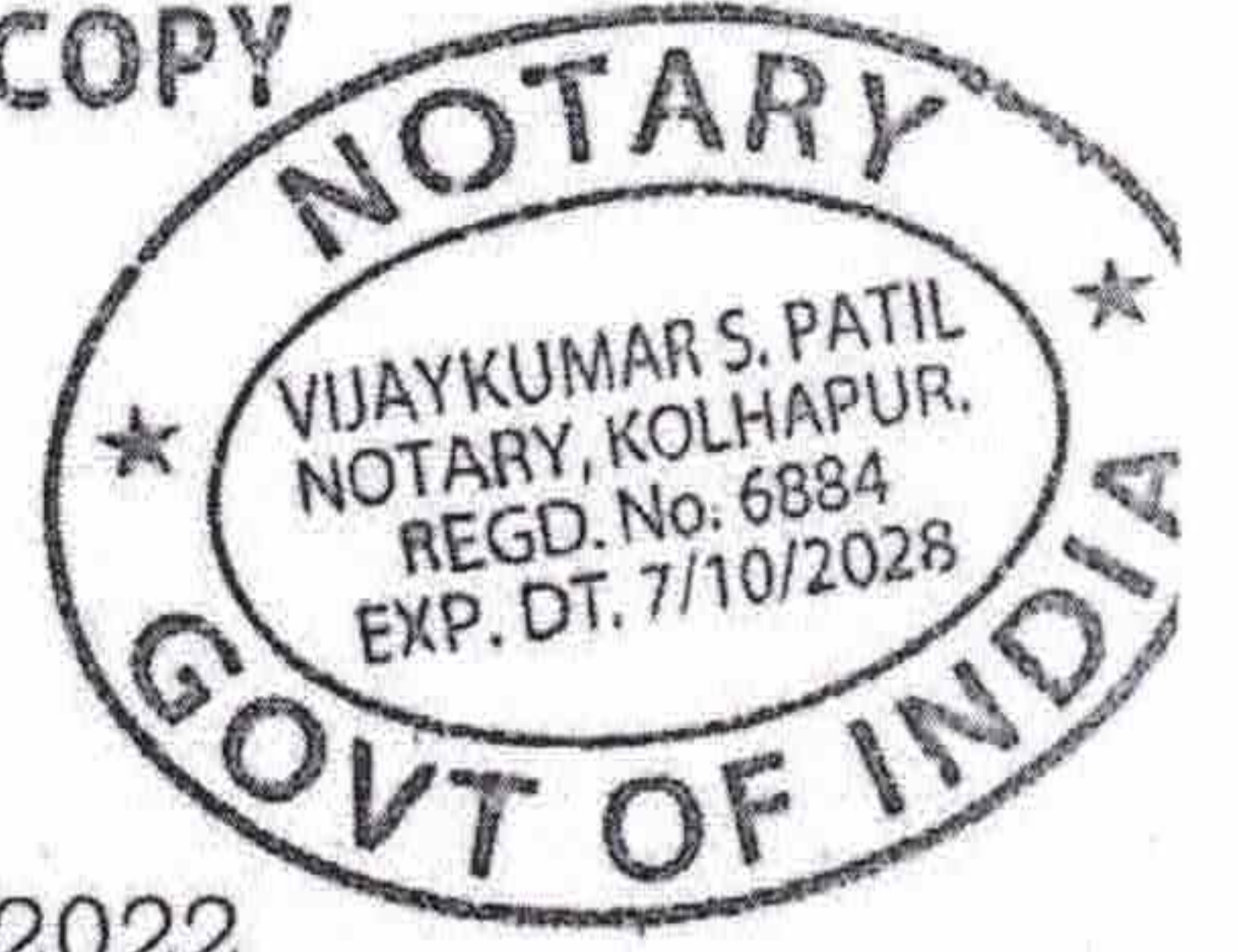



- 3) **Objectives of Society**
 - 1) Opening Balwadi for Kids, Provide them free education nutrition food, cloth, Slate, notebook etc.
 - 2) Opening Primary, Secondary School & Colleges to education for young generation.
 - 3) Opening Public Library for young generation, so that they can get books for reading on lowest cost.
 - 4) To celebration 26th January, 15th August, Shivajayanti, to organize lots of competition of sports as well as cultural activities.
 - 5) To develop exercise interest in young generation provide them education of exercise & athletics etc.
 - 6) Propaganda of Education.
 - 7) Education for adult and opening of girls schools, so that they can get primary & secondary education.
 - 8) To start New Primary School, Asylum schools, Ayurvedic Medical college & Hospital, Homeopathic Medical college & Hospital, Dental College & Hospital, M.B.B.S. College &

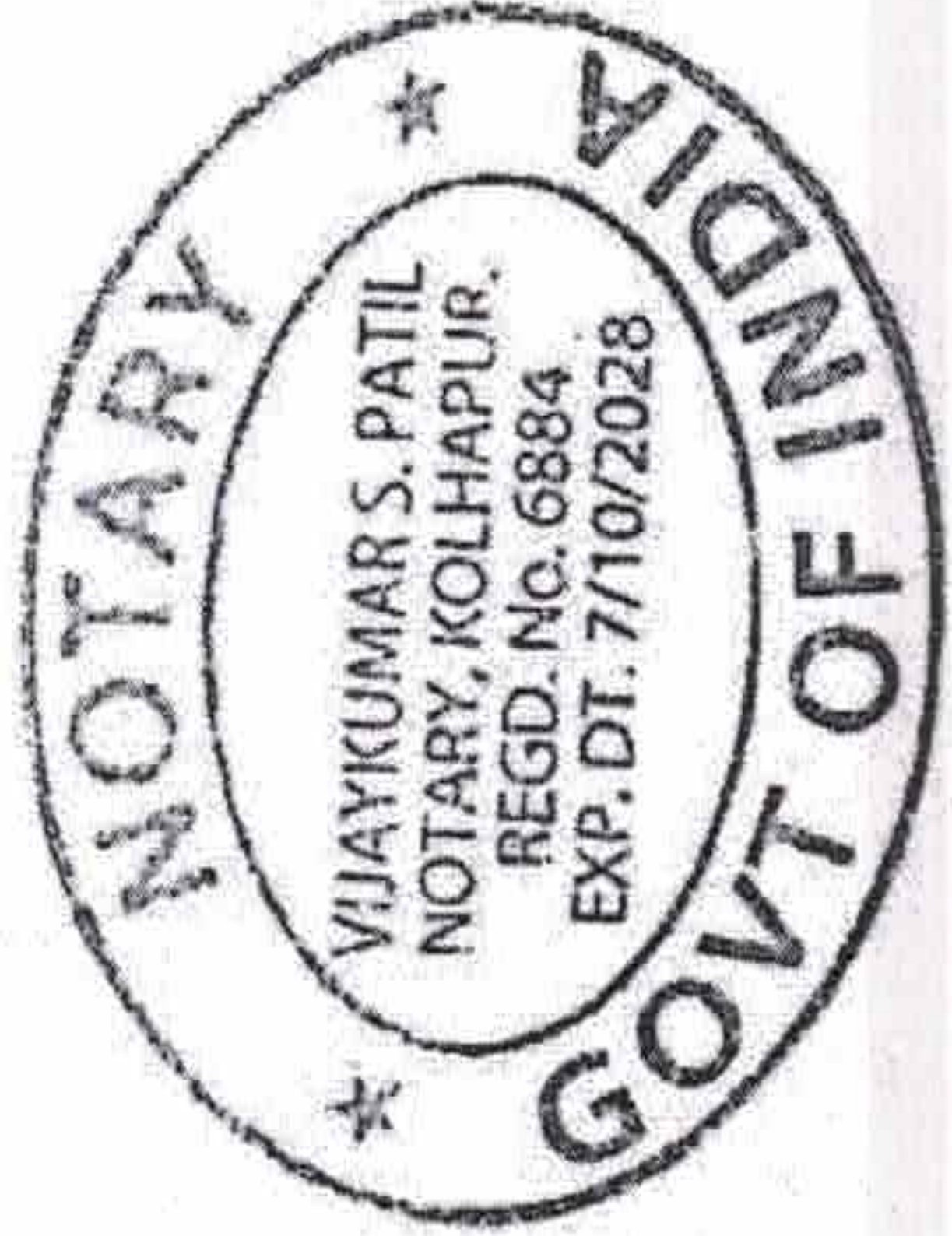

Public School, I.B, Public School, Skill development Programme Training Centre, Training Centre, Nursing College, various schools and colleges in Agriculture Sector, Old Age homes, Residential Schools, Hostels, to promote boys-girls through swimming tanks, orphanages, Hostels for Paritakta women, music school, sugar schools, Dairy and animal husbandary rearing, rural hospitals, college, hospital, Pharmacy College, in this additional provisions in objectives for Scheduled Castes, Scheduled Tribes, other Scheduled Tribes and other tribes also for all the castes and religious boys and girls.



- 9) The students from all types of caste, religion are admitted in the institution.
 - 10) To take in hand the give and take programmes in educational area development and organize seminars, shivirs.
 - 11) For above programmes to open educational branches, colleges in district or in Maharashtra.
 - 12) To take in or give out custody of pre-established educational institutions or any other branches of education for giving education if necessary.
 - 13) To start various schools, colleges purchase land, building, construct building.
- 4) **Authorised Year of Society:** 1st April to 31st March.
 - 5) **Societies Area :-** Society area is limited to Maharashtra State.
 - 6) **Membership**
 - 1) Any one who is above 18 years and who has admitted the aims & attitude of society can be member of society. Yearly subscription of society will be Rs.10 (Ten). The

person wishing to become a member have to send printed application with his complete share or part of share with subscription along with recommendation of two members for sanction from Executive Body and after receiving proper sanction then the rights of the membership will be eligible for applicant person.

- 2) Governing body of society shall maintain a list of members within the meaning of section 15 in the form of schedule VI.
- 3) A copy of schedule VI, rules & regulation is annexed with.

7) Kinds of member

- 1) **Founder member** :- Who will cause to establishment of society is become member by paying Rs. 10 as entry fee will mentioned as be founder member.
- 2) **Ordinary member** :- Member who will pay subscription of Rs.10 or annual Rs.10 regularly will be mentioned as ordinary member.

8) Right of member

- 1) Member's can participate in every work. They can vote in annual meeting, participate in discussion related to societies work, governing member, income & expenditure, balance sheet, budget, report etc. Candidate should send his form at societies office within 1 month after end of year on 31st March. For that purpose they can inquire to president or secretary, such instruction will be given in office. Governing member would be selected from the member, who will be present for annual meeting if governing member form will less.

9) Cancellation of membership

- 1) On resignation insolvency, punishment for criminal offence & moral turpitude or
- 2) The members who bars rules of society and wellbeing directly and indirectly by destructive means and in disciplined conduct, any member, membership can be cancelled for ever or for limited period on recommendation of governing members by majority in general meeting. But such member has opportunity to explain his side. (such opportunity will be given before governing body)
- 3) Any member who has not paid his monthly subscription regularly & dues remains for 3 months, annual

subscription not paid up to 20th June, his membership may be cancelled as per right of governing body.

10) Restrictions

- 1) No any member should discloses the secrets of societies aims or daily activities. If there is any misunderstanding regarding governing body or whole society, it should be put before president of governing body & thereafter before annual general meeting. If such misunderstanding is related to abovementioned person, then any senior governing member should be appointed as a arbitrator & his decision will be final. But in all situation such disputes disclosed in news paper, or through open public meeting & propaganda of such thing before appointing arbitrator & before clarification of misunderstanding anybody raised it in court or before police, his membership is liable to cancel. But on recommendation of governing body society may file criminal complaint against any member on his misconduct or wrongful act against society.

11) Governing Body


There will be 15 members in governing body including president, vice-president, Executive President, secretary, Joint secretary, Cashier such 6 dignitary officers & remaining will be governing members.

If necessary governing body has right to extent governing body upto 21.

If necessary, on permission of presidents, invitee person can remain present for meeting. But he has no voting right. Governing body selection will be held after every **Five** years by majority votes in annual general body meeting. If there will be any vacancy in governing body, it should be fill up by majority by governing body members. Member's list should be sent without any excuse to Charity Commissioner, Kolhapur, Division Kolhapur. Under Sec. 4 of societies registration Act 1860 & regulation of 1971 list of schedule II is annexed with this rules & regulation.

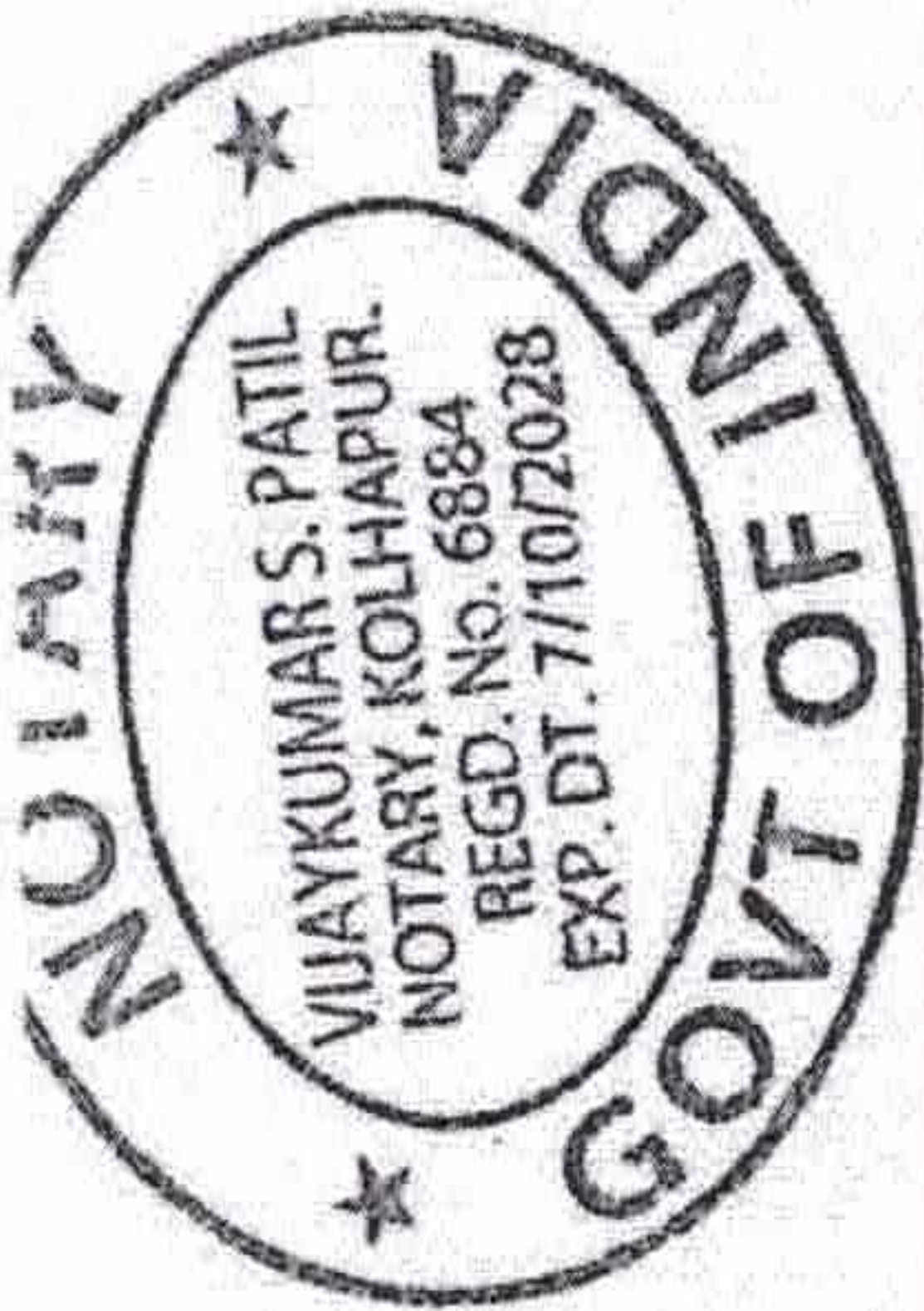
12) Governing Body's duties & rights

- 1) To do daily work of society, to appoint the staff, transfer or retirement, economic transaction, to add new member & maintain list to such members under rules no.5(2) & 3 & such other work.

- 2) To prepare internal accounts, government account through inspector & prepare income & expenditure, report & organize Annual meeting to maintain societies accounts under provisions of society registration act 1860 to audit it through auditor annually & to make provision to sent to Charity Commissioner Kolhapur, Division Kolhapur within certain limit.
- 3) To decide new resolutions, submit the budget by preparing before annual meeting.
- 4) To accept amendments in societies rules & regulations, new work or other recommendation in annual meeting.
- 5) To supply information of persons concerned with society registration act 1860 to Rule 4(a) and year 1971 of society registration Charity Commissioner Kolhapur, Division Kolhapur
- 6) To perform other necessary act with due procedure.


13) Meeting of governing body

Meeting shall be held at least once in two months for performance of regular daily work. For that purpose, there will right to call emergency meetings by giving 4 days notice to members. Meeting will not be illegal if notice will not received by any member though sent by register post. In some special occurrence to take decision for emergency work, secretary shall with permission of president, ask opinion of governing body members & on majority the ordinary / resolution is supposed to passed or rejected & sanctioned accordingly. Governing bodies corem should be 8. President or Vice-President should be present for meeting. Governing body member remained absent without prior permission for constant three meetings, his governing body membership will be cancelled automatically & new member will selected his tenure will equal to governing body.

14) Incumbent their duties

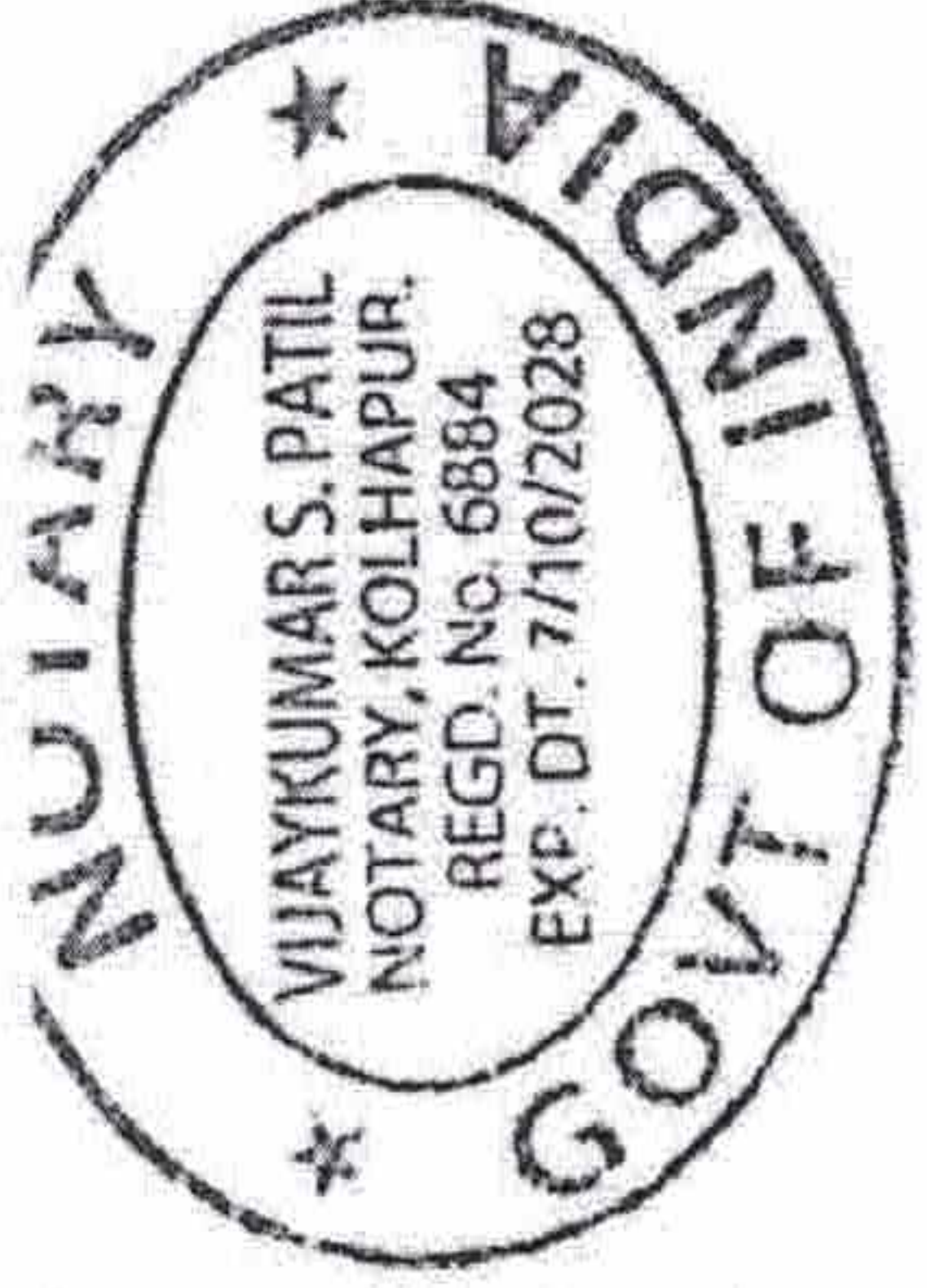
President

- A) To organize importantly annual meeting, general meeting, governing body meeting under presidentship.
- B) Supervise & control over all activities of society.
- C) Right of casting of vote in case of equal voting.
- D) If secretary fails to perform his duties regarding society, then under his own rights he can governing bodies or annual meeting 4 to take decision regarding Secretary.

- E) To sign on documents of society & to perform other such acts.

Secretary-

- A) To perform daily work of society as per societies objects & instruction of governing body. To inspect documents & sign on it.
- B) To organize time to time the governing body's & annual meetings with pre permission of president & maintain it's report.
- C) Lettering for society, maintain its record & maintain income & expenditure.
- D) Remain as mediator between governing body, society a staff, to inspect on their daily work & maintain register, receipt book etc.
- E) To deposit the collected sum in societies bank & perform other related activities Rs.100/- can be given to Secretary for daily expenditure & Rs.150/- can be expended with prior permission of president on permitted expenditure. But such expenditure is totally passed in governing body meetings.

Vice-President


- A) To perform all the liability of president in president's absence.

15) Annual General Meeting

- A) Societies annual general meeting shall be held within six months from completion of official year. For that purpose all governing body member should show due diligence. But in all conditions if annual meeting is not held with in six months after completion of official year, then president should call it in his own rights.

B) Rules of annual meeting

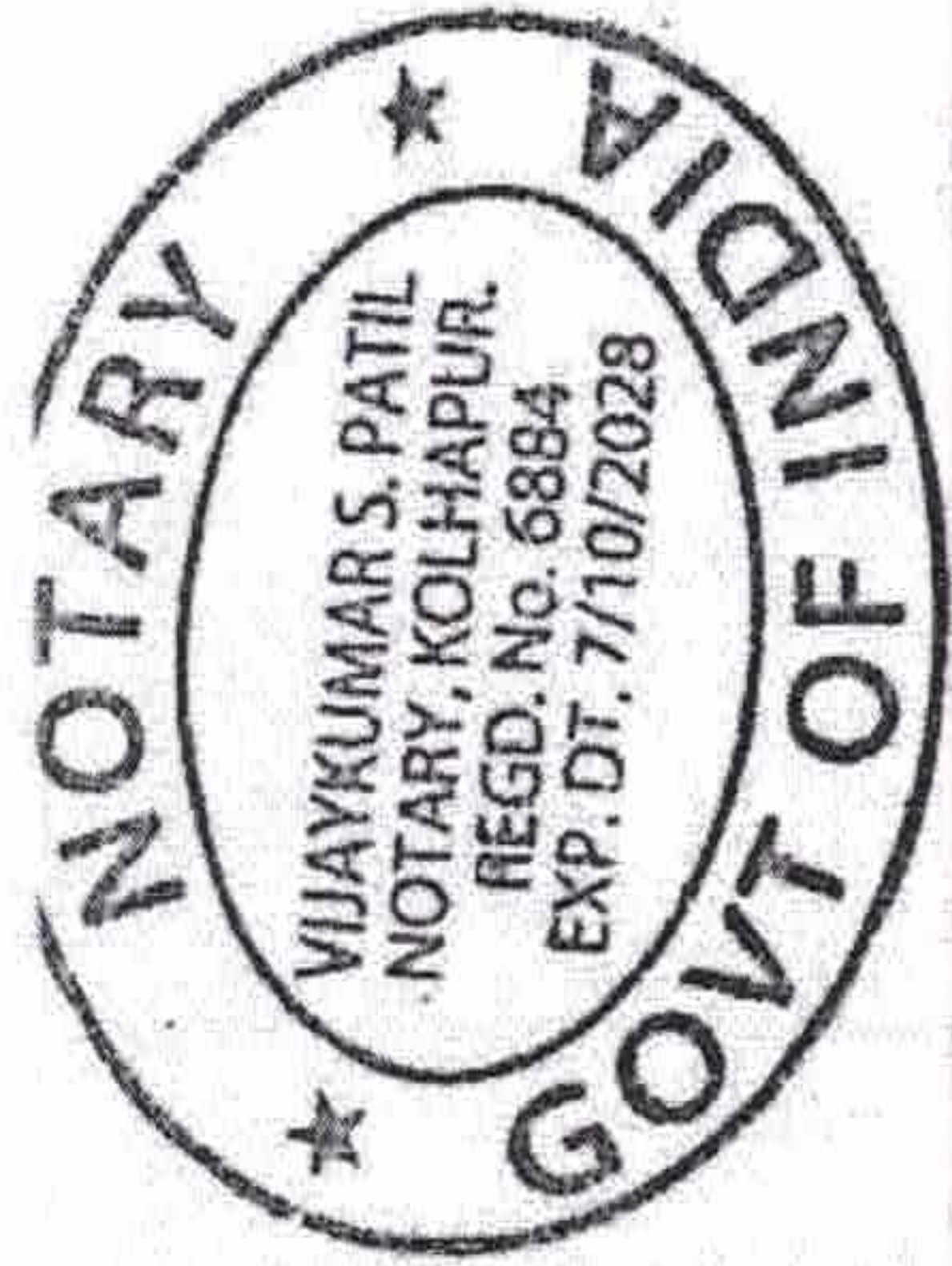
- 1) Annual meeting shall be held on same day, place & time which was fixed by governing body.
- 2) It is best if the annual general body meeting is given in local newspaper but this will not be binding.
- 3) Annual meeting notice should be given before 15 days.
- 4) After sending notice if, any member not received notice though sent by register, it will not affect the sanctioned work in meeting.

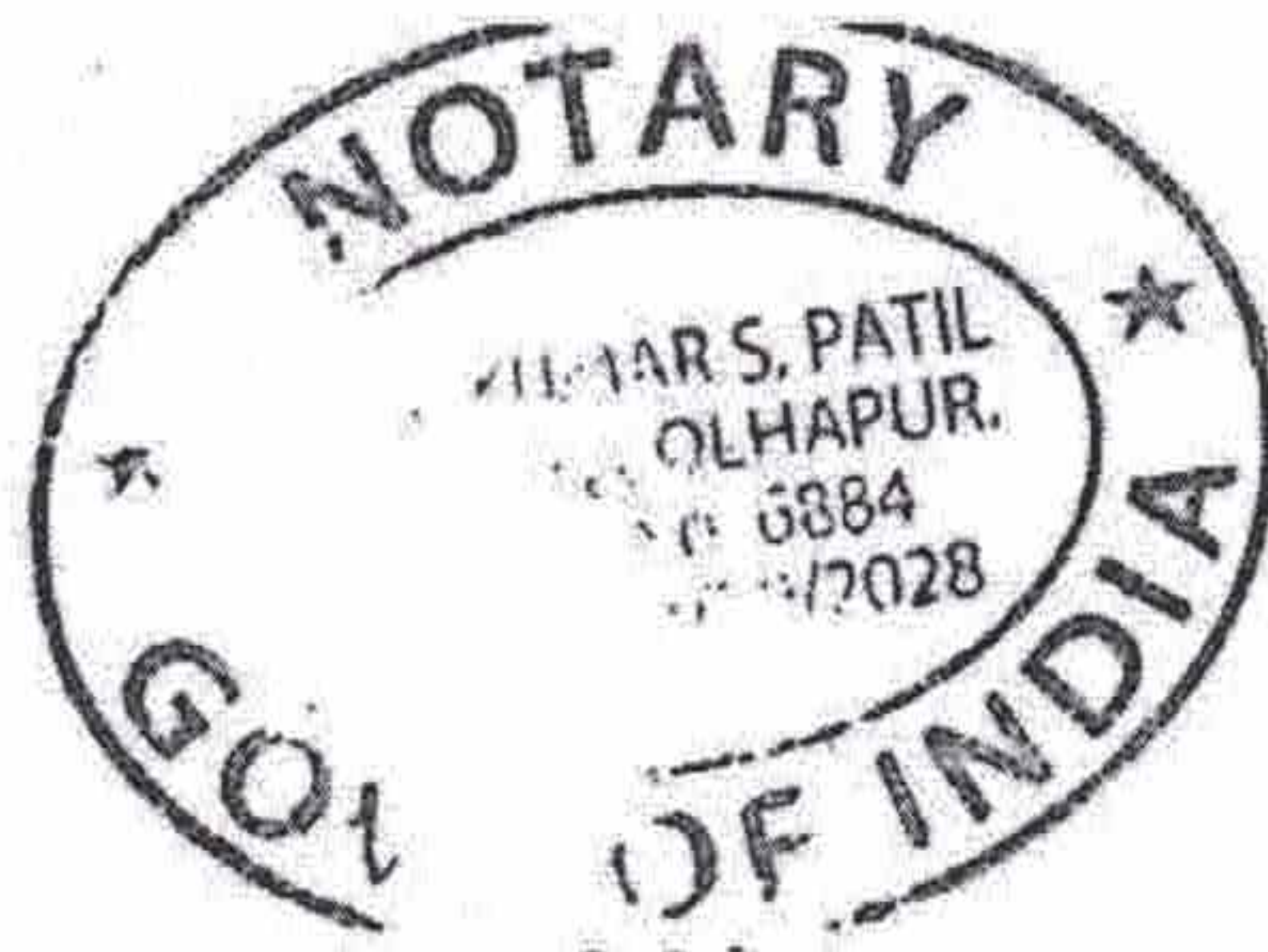

- 5) Current members should participate in the working of annual general body meeting.
- 6) Any useful person for society can be invited as invitee or inspector by prior sanction in governing body meeting but he has no voting right.
- 7) Corum for meeting should be 2/5. Meeting postponed for corum should be called after ½ hour but there is no need of corum for that meeting.

16) Duties in Annual General Meeting

- 1) To sanction the minutes of last meetings, report produced by governing body, accounts & calculation & budget.
- 2) To elect the officers in governing bodies meeting.
- 3) To discuss about aims, policy & activity.
- 4) To perform acts which was brought with the permission of President or suggested by other members by giving notice.

17) Additional General Meeting

Any additional meeting can be call special purpose to show any important matters in front of governing body member. All rules of annual general meeting followed except rules of corum. If written application is filed by ¼ officers (governing body member), president shall call additional general meting.

18) Amendment in Rules & Regulations

Amendment should be done in the Schemes of society as per clause No.50 A (3) of Maharashtra Public Trust Act 1950.

19) Funds & its investment / disposal

To raise funds for society the kinds are used such as collect donations, collect loans by means of interest, without interest, may be used collecting subscription, by legal way through loan on interest, without interest, by cultural programme or by any other legal way & also by subsidy from government, non-government or private subsidies.

Society's money should be deposited on society's name in account of society in Bank. But it should not be deposited with any private person or institution.

Any transaction of withdrawal of money should be carried out with the joint signature of any two persons from president, vice-president & secretary.

Secretary should not keep an amount with himself & deposit it into society's bank account if amount is more than Rs.250.

The use of Funds/earning of society should be done only for the completion of the objects of the society.

20) Winding up society

If by any reason society would be winding up, it should be according to provision of society regulation act 1860.

Also at the time of dissolution of Trust for some reason if there is any movable and immovable property it will be dissolved in the Trust having the same objectives. After completion of all the legal formalities in the trust the working of the trust will be stopped or Trust will be dissolved.

21) Regarding Non-Transformation of the Society

Any person cannot repeal the Society. As the possession of the society shall not remain with any person this society should be non-transformational.

22) Beneficiary

The Trust fund is not person related it should be society related. Society will be part of community. In any situation, the society's beneficiary should not be of personal form.


